Guaranty

The breeder is held responsible for the health of the puppy as long as he belongs in his possession. If during this period the puppy needs minor medical assistance, the breeder engages himself to have him taken care of and pay's the fees. If a serious illness is diagnosed or if the puppy came to die's during his stay at the breeder's, the breeder engages himself to give the buyer another puppy at the same cost value but the buyer must wait for the next litter of puppy's which can take 12 month or more. Or if he decides to choose a puppy of greater value, the buyer must assume the difference. The breeder will do everything in his power to not let the buyer wait too long for his replacement. The deposit remains the possession of the breeder and is applicable for the next puppy, and is not refundable.

During the first 10 days at the buyers, if the puppy was to decease, the breeder would require an autopsy report signed by a licensed veterinarian indicating the reason for the puppy's death. If the autopsy reveals without a doubt that the death of the puppy is due to a hereditary illness or an incurable disease described in the guarantee by the breeder, the puppy will be replaced and this as soon as the next batch of birth by a puppy of same value or if the buyer decides to choose a puppy of superior value and to assume the difference. The fee's incurred for the care by the veterinarian also for the autopsy rapport is at the buyer's expense.

The problem's occurred following hypoglycemia is not the responsibility of the breeder. The buyer accepts these conditions even at the delivery of the puppy. In no way does the breeder take responsibility to replace the puppy that dies due to a lowering of the sugar and this also at the same time of the delivery. The buyer has been advised that this small race is subject to lowering of the sugar count and is related to some health problems.

The breeder will not replace a dead puppy if the cause is due to a fall. The puppy must never be left alone under the care of a child. It is preferable that you restrain your puppy from some places in the house to prevent accidents.

Guaranty

The breeder confirms that the puppy was by a licensed veterinarian. The puppy was vaccinated (the basic vaccines for his age). The vaccination given to the owner will indicate which vaccines have been administered to the puppy. The puppy has been de-wormed at least once. Other vaccines and treatments are at the buyer's expense. The guaranty is for a period of ten days which covers the following infections:

Parvovirus

Distemper

Para-influenza

Rabies

The guaranty takes effect as soon as the puppy leaves. No other kind of viral illness or infection is covered by this guarantee.

For the puppy sold for reproduction no guarantee applies, we cannot predict if a male or female is apt to reproduce. The buyer accepts these conditions and accepts to take the risks. It is preferable that the buyer keeps the puppy from having any contact with other animals, no matter what kind before he receives the re-call vaccinations. The buyer engages himself to have the puppy examined in the next 5 days of his leaving by the veterinarian of his choice. In no instant or case, will the breeder be responsible of the puppy's health, once he has left the premises.
